INDIAN ADULT EDUCATION ASSOCIATION Annual Report 2009

It gives me great pleasure to greet you all to the General Body Meeting of the Indian Adult Education Association and to place before you the Annual Report of the Association for the year 2009.

Before enumerating the achievements of IAEA in the year 2009, I would like to brief you about 'Sakshar Bharat' - Mission 2012 which is the major adult education programme in the Eleventh Five Year Plan.

The Prime Minister, Dr. Manmohan Singh launched 'Sakshar Bharat', a centrally sponsored scheme of Department of School Education and Literacy, Ministry of Human Resource Development, Government of India on the International Literacy Day on September 8, 2009. It aims to further promote and strengthen Adult Education, specially of women, by extending educational options to those adults who having lost the opportunity of access to formal education and crossed the standard age for receiving such education, now feel a need for learning of any type, including, literacy, basic education (equivalency to formal education), vocational education (skill development), physical and emotional development, practical arts, applied science, sports, and recreation.

To impart functional literacy to non-literates in the age group of 15-35 years in a time bound manner, the National Literacy Mission (NLM) was launched in 1988 and it continued through Ninth and Tenth Five Year Plans. By the end of the Tenth Five Year Plan (March 2007), NLM had covered 597 districts under Total Literacy Campaign, 485 districts under Post Literacy Programme and 328 districts under Continuing Education Programme. As a cumulative outcome of these efforts, 127.45 million persons became literate, of which, 60% learners were females, while 23% learners belonged to Scheduled Castes and 12% to Scheduled Tribes.

Despite significant accomplishments of the Mission, illiteracy continues to be an area of national concern. Though precise number of non-literates at this stage is not available and will be known only after 2011 census, 2001 census had revealed that there were still 259,52 million illiterate adults (in the age group of 15+) in the country. While further accretion into the pool of adult illiterate persons is expected to recede significantly on account of enhanced investments in elementary education and a reverse demographic trend, addition to this pool cannot be ruled out altogether on account of relatively high school drop out ratio. Wide gender, social and regional disparities in literacy also continue to persist. Adult education is therefore indispensable as it supplements the efforts to enhance and sustain literacy levels through formal education.

It was, therefore, considered necessary to continue the NLM during the XI Five Year Plan period. While acknowledging, in principle, the need for continuing and strengthening further the efforts to promote Adult Education, the Planning Commission agreed to the continuance of NLM during the XI Plan provided it was appraised de novo and modified suitably to meet the contemporary challenges. The programme was accordingly subjected to extensive in-house and external review and evaluation.

This in-depth appraisal had revealed certain inadequacies in the design, architecture and mode of implementation of the programme, most conspicuous being, non-viability of a single pan Indian solution, limitations of voluntary approach, limited involvement of the State Governments in the programme, lack of convergence, weak management and supervisory structures, lack of community participation, poor monitoring and inadequate funding.

Meanwhile, the Government announced that literacy would be its key programme instrument for emancipation and empowerment of women. Efforts of the Government to give impetus to school education, health, nutrition, skill development and women empowerment in general are impeded by the continuance of female illiteracy. Government expects increase in female literacy to become a force multiplier for all other social development programmes. However, this is only the instrumental value of female literacy. Its intrinsic value is in emancipating the Indian woman through the creation of critical consciousness to take charge of her



environment where she faces multiple deprivations and disabilities on the basis of class, caste and gender.

In the context of Government's overall policy aimed at empowerment of women and in recognition of the fact that literacy, especially female literacy, is a pre-requisite to socio-economic development, it was considered imperative that the National Literacy Mission, as a programme instrument, be recast with an enhanced focus on female literacy. It is also felt that such a repositioning of the mission would have a very positive impact on re-energising the literacy movement that, after an initial decade of spirited social mobilization, had waned over two decades of its operation.

To recast the mission, a protracted process of countrywide consultation with stakeholders was gone through. A series of consultative meetings were held across the country with representatives of the government of States, NGOs, literacy practitioners, managers, administrators, State Resource Centres, universities, social activists and other stakeholders. The broad strategy was also discussed with Education Secretaries of all States on 30.6.2009. The Council of National Literacy Mission Authority considered and approved the strategy on 21-8-2009 and thereafter it was placed before Central Advisory Board on Education on 31-8-2009.

The general opinion of the stakeholders, expressed during the consultations, was that the new mission ought to take note of considerable demand for female literacy generated on account of large scale changes at the grassroot level and the new opportunities that have been created over the past several years, most notably, the increasing vibrancy of Panchayati Raj Institutions, post 73rd Constitution Amendment, the shift to the model of Self Help Groups that operate through collectivities for self-employment programmes, the massive new organisational capital being forged again through work collectives such as National Rural Employment Guarantee Act, Joint Forest Management Groups etc.

It is in this background that Sakshar Bharat has been devised as the new variant of National Literacy Mission. Sakshar Bharat will cover all adults in the age group of 15 and beyond though its primary focus will be on women. The scheme has not only been relieved of the shortcomings noted in its preceding editions, but also, several new features added to it. Basic Literacy, Post literacy and Continuing Education programmes, will now form a continuum, rather than sequential segments. Besides, the volunteer based mass campaign approach, provision has been made for alternative approaches to adult education. Jan Shiksha Kendras (Adult Education Centres), will be set up to coordinate and manage all programmes, within their territorial jurisdiction. State Government, as against the districts in the earlier versions, and Panchyati Raj institutions, along with communities, will be valued stakeholders. Vigorous monitoring and evaluation systems will be installed. Last, but not the least, budgetary support has been enhanced substantially.

The Mission has four broad objectives, namely:

- Impart functional literacy and numeracy to non-literate and non-numerate adults
- Enable the neo-literate adults to continue their learning beyond basic literacy and acquire equivalency to formal educational system
- Impart non and neo-literates relevant skill development programmes to improve their earning and living conditions
- Promote a learning society by providing opportunities to neo literate adults for continuing education

The principal target of the mission is to impart functional literacy to 70 million adults in the age group of 15 years and beyond. Auxiliary target of the mission is to cover 1.5 million adults under basic education programme and equal number under vocational (skill development) programme. Within these targets, the Mission will primarily focus on, but not limited to, women. Schedules Castes, Scheduled Tribes, Minorities, other disadvantaged groups and adolescents in rural areas in low literacy States will be other focused groups. For each focused group and area, there will be a specific target and for each target, an explicit approach and strategy.

Functional Literacy Programme

Literacy Programme will aim to achieve the first objective of the scheme, that is, 'Impart functional literacy to non-literate adults'. Functional literacy, in context of the programme, implies achieving self reliance in Reading, Writing, Arithmetic (Numeracy) and becoming aware of the causes of one's deprivation and moving towards amelioration of their condition through organization and participation in the process of development; Acquiring skills to improve the economic status and general well being; Creating an aware and responsible citizenry (Imbibing values of national integration, communal harmony, conservation of the environment, women's equality, and reproductive behaviour etc.).

The programme entails identification of non-literates through a survey, area wise mapping of their learning needs and imparting them instructor based teaching of about 300 hours spread over 3 months or beyond, depending on motivation of the learner and local conditions. Successful completion of the 300 hours of instructional learning would enable the learner to read and comprehend unknown text (news paper headings, road signs etc); apply skills of writing in day to day activities like writing applications and letters and filling up of application forms, etc., and compute simple problems involving multiplication and division. A certificate will be issued to every successful learner based on a professional evaluation of learning outcome. This will open up opportunities for further education through Open Learning Systems. Classes will be convened at such time and venue as would be suitable to the learners. SLMAs will be under obligation to arrange for the use of Sarva Siksha Abhiyan (SSA) school buildings, during out of schooling hours and holidays, to be used for conducting literacy classes and related activities.

Basic Education Programme

This programme is designed to achieve the second objective of the scheme, namely, 'Enable the neoliterates to continue their learning beyond basic literacy and acquire equivalency to formal educational system'. Arrangements will be made to enable young adults to continue their learning till they are able to achieve equivalence levels with Grade III, IV, V, VI, VII and VIII and beyond in the formal school system or through the Open Learning System. The Open Basic Education (OBE) programme initiated by the National Institute of Open Schooling (NIOS) and other Open Schools will be taken as the starting point. While formulating equivalency programmes, the life experience and local knowledge systems of the adult learners will be taken into consideration.

Vocational Education (Skill Development) Programme

For furtherance of the third objective of the scheme, that is, 'Equip non and neo-literates with vocational skills to improve their living and earning conditions', suitable skill development training will be imparted to



those having rudimentary levels of education or no education. Jan Shikshan Sansthans (JSSs), set up under the Scheme for Assistance to Voluntary Agencies for Adult Education and Skill Development of DSEL, will be institutionally networked with the Adult Education Centres so that they could impart skill development training, as well as literacy linked vocational training. JSS, in coordination with the District Implementing Agency, will enlist neo-literates for appropriate skill development training. Besides specific activities for which a specific budgetary provision is available under the Mission, JSSs will utilise their programme budget to impart vocational skill training.

Parallel efforts will be made by the SLMA and District Implementation Agencies for developing synergies with other agencies in the public as well as private sector for enhanced opportunities of skill development training at the gram panchayat level.

Continuing Education Programme

Continuing Education Programme (CEP) is aimed at achieving the fourth objective of the Scheme that is, 'Establishing a learning society by providing opportunities to neo literates and other targeted beneficiaries for lifelong learning'. The programme recognizes increased demand for learning generated by Basic and Post Literacy Programmes and the potential need of adult learners to further enhance their skills on their own terms and at their convenience. CEP, as the very name suggests, will not have a fixed time frame as in the case of the other three programmes, but will be organized on a continuous basis. The approach is to create a sustainable learning environment so that learners are encouraged to continue with their literary aspirations and take advantage of the programme facilities to satiate their learning appetite.

The Programme will provide facility of a library and reading room, which would be gradually provided with other contemporary ICT devices. Short-term thematic courses like Health awareness/ care, Food and nutrition, Water conservation / drinking water / sanitation, Population development education issues - AIDS/STD, Sex education, Consumer awareness / Consumer rights, Legal literacy, RTI or any other topic of interest and relevance to the lives of the learners will also be offered under this programme.

To implement the programme, 1.70 lakh Lok Shiksha Kendras (Adult Education Centers) will be established in Panchayat villages of the districts covered under the programme. It will subsume the already sanctioned Continuing Education Centers (CECs) in a particular district. Existing CECs and the nodal CECs in the districts not covered under the programme will have to be closed down, unless the Government of States wish to run them at their own cost through Public Private Partnership or otherwise. Gram Panchyats may as well be given this offer. Specific approval of NLMA will be required to continue an existing CEC under this programme.

A Lok Shiksha Kendra will act as a centre for registration of learners for all teaching learning activities in their jurisdiction; Nerve center for literacy campaign including identification of the learners and volunteers, batching and matching of the learners with suitable Volunteers as well as their training, providing literacy kits to learners and volunteers, keeping track of the progress made by each learner-volunteer group; Nodal centre for mass mobilization activities; Technology center; Center for thematic courses on behalf of other departments such as Agriculture, Animal Husbandry and Veterinary, Fisheries, Horticulture, Sericulture, Handloom, Handicrafts, Health, Education, Rural Development, Urban Development, Women and Child Development, SC, ST, OBC welfare, Panchayati Raj, Science & Technology etc. or based on local demand; Library and reading room; Venue for group discussion; Vocational and skill development and extension facility for other departments; Center for promoting sports and adventure and recreational and cultural activities; A composite information window and Data center for Adult education besides any other activities related to the mission.

Non-Government Organisations

Alliance between GOs and NGOs would be further strengthened. NGOs and other groups that have



demonstrated long-term commitment to issues of adult education and which have an established and unsullied track record of performance in this area will be drawn in as resource groups at all levels. Voluntary Sector will be encouraged to take up activities under any programme of the Mission as well as innovative programmes aimed at achieving its objectives for which they may be provided grant-in-aid at the approved cost norms. Selection of the NGO will be the responsibility of the SLMA or the sub-state implementation agency as decided by the SLMA. However, NLMA may select any NGO to assist it in any aspect of the Mission.

Activities carried out by IAEA during the Year 2009

(1) Fifty-Seventh All India Adult Education Conference



The Fifty-Seventh All India Adult Education Conference was organized at Kolhapur, Maharashtra from December 19-21, 2008 in collaboration with the Department of Adult and Continuing Education and Extension Work, Shivaji University. The conference was held in the auditorium of Bhasha Bhavan, Shivaji University. The theme of the

Conference was "Lifelong Learning : Opportunities and Challenges". In all 227 participants from 21 States - Andhra Pradesh, Assam, Bihar, Chhattisgarh, Delhi, Goa, Gujarat, Jammu & Kashmir, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Manipur, Meghalaya, Nagaland, Orissa, Rajasthan, Tamil Nadu, Uttar Pradesh, Uttarakhand and West Bengal attended the conference. The sessions

were divided into inaugural, four plenary, special interest group discussions and concluding session. Prof. M.M. Salunkhe, Vice Chancellor, Shivaji University, Kolhapur inaugurated the conference.

The inaugural session started with the lighting of ceremonial lamp by the Chief Guest. The Chief Guest and other dignitaries were welcomed with flowers and the sacred 'Khata' brought from H.H. Dalai Lama's Tibet Monastery, Bodh Gaya by Shri A.H. Khan, Vice President, Indian Adult Education Association (IAEA).

Prof. M.M. Salunkhe, Vice Chancellor, Shivaji University in his inaugural address said that Shivaji University established in 1962 is serving for the cause of downtrodden and backward sections of the society for long. In its 46 years of existence, the University has made substantial progress in various areas with the financial assistance from leading scientific organizations. He also said that the University is providing not only educational



needs for the students but also the economic development of the area covered by the University. Prof. Salunkhe explained in detail various activities being carried out by the Department of Adult and Continuing Education and Extension Work of his University, which is celebrating its Silver Jubilee Year and appreciated its useful services to the students and community.

Smt. Shobhana Ranade, a veteran social worker and the Guest of Honour in the inaugural function while presenting her paper on "Literacy to Change Today's World" narrated a few of her experiences in life which made her to devote more attention to women literacy and child development through the programmes of All India Committee for Eradication of Illiteracy Amongst Women. She paid rich tributes to late Smt. Lakshami N. Menon, the founder of the All India Committee from whom she claims she had got a lot of enthusiasm and devotion.

Shri Kailash Choudhary, President, Indian Adult Education Association delivered the presidential address. He

briefly mentioned the history of Indian Adult Education Association and its role in the development of lifelong education and learning. He fondly recalled the association of Dr. Zakir Hussain, former President of India with IAEA as Vice President of the organization. Shri Choudhary said that in 1964 a conference was organized by IAEA under the chairmanship of Dr. Mohan Sinha Mehta, the then Vice Chancellor, Rajasthan University in which a resolution was passed to start Adult Education Departments in all the Universities in the country. However, he felt sad that the departments which acted as nodal institutions for



extension work and outreach activities have been closed in a few states with the result the outreach activities almost have come to a stand still.



Dr. Madan Singh, General Secretary, Indian Adult Education Association presented the vote of thanks to the Chief Guest, the Guest of Honour, the invited guests and delegates.

On the second day of the conference - December 20, 2008, a General Session was held in which Shri Bhaskar Chatterjee, Principal Adviser, Planning Commission, Govt. of India was the Chief Guest. In his address he paid rich tributes to the political leadership, administrators and the literacy functionaries who worked for the success of the programmes of National Literacy Mission during 1991-2001 due to which the country could achieve the literacy rate by over 12 percent. According to him, this achievement is still considered as



the highest and it may not be possible to repeat the same in the future. He was of the opinion that today literacy programmes are at the crossroads and need special attention. He was feeling sad that even after 20 years of the establishment of NLM, no alternative has been thought off as plan after plan the programmes were continued based on the original objectives set for the mission. He raised doubt that keeping in view the present conditions, it may not be possible to achieve 80 percent literacy rate set by the Planning Commission by the end of XI Five Year Plan period.

Shri Bhaskar Chatterjee further said that even though a large amount has been allocated for education in XI Five Year Plan, much of the amount will be spent to establish institutions of excellence like IITs, IIMs and Central Universities and also for Sarva Shisha Abhiyan. The amount allocated for adult education programmes is a meagre one. He said that even the institutions like SRCs and JSSs which have done an excellent work have not been found a favour with the Ministry of Finance in XI Five Year Plan. However, there are efforts to reformulate the programmes of adult education and there is a hope that adult education sector will get a sizeable amount as budget. He also said that there is an urgent need that the University Departments of Adult Continuing Education and Extension also get their due share and pride in the field of adult education for which discussions will take place at different levels - Directors, Vice Chancellors and UGC.

There were seven Special Interest Groups worked on various topics. They were:

The 57th All India Adult Education Conference on Lifelong Learning : Opportunities and Challenges, hereby solemnly declares that, come what may, we have to make Lifelong Learning a Lifelong Mission for one and all - educated and uneducated.

Recommendations

- (i) Involve NGOs, CBOs, SHGs, PRIs and other agencies for promoting Continuing Education / Lifelong Education.
- (ii) Establish proper coordination between the Universities, SRCs, JSSs and implementing agencies.
- (iii) Impart effective and need based training to the functionaries of Continuing Education / Lifelong Education.
- (iv) Develop innovative and creative training modules for all levels with the help of experts from SRCs, JSSs, NGOs and Universities.
- (v) Motivate and orient the political leaders, Panchayat leaders and local government officials.
- (vi) Panchayat / Local Government institutions provide proper infrastructure facilities for Continuing Education / Lifelong Education.
- (vii) Encourage Quality and Action Research on Continuing Education / Lifelong Education.
- (viii) Allocate separate funds for Continuing Education / Lifelong Education.
- (ix) Ensure proper monitoring and evaluation in order to sustain the Continuing Education / Lifelong Education.

(2) Nehru and Tagore Literacy Awards Presentation

The Indian Adult Education Association instituted two Literacy Awards, one in the name of Nehru in 1968 to commemorate the distinguished services of Pandit Jawaharlal Nehru and is given annually to individuals/institutions for the

promotion of adult education and the second one in the name of Tagore in 1987 to commemorate the 125th



birth anniversary of the great poet Gurudev Rabindranath Tagore and is given annually to individuals/institutions for promotion of literacy among women.

The awards for the year 2006, 2007 and 2008 were presented in a function on July 31, 2009 at Ramada Plaza, New Delhi. Hon'ble Dr. APJ Abdul Kalam, Former President of India was the Chief Guest.

The recipient of Tagore Literacy Award for the year 2006 was Smt. Krishna Mohanty, Member, Standing Committee, Utkal Navajeevan Mandal and Secretary Bajiraut Chhatravas, Angul, Orissa for her work in the field of literacy for the last 50 years, for 2007 was Smt. Lakshmi Rupal, Retired Principal, School of the Steel Authority of India, Durgapur, West Bengal and President, Luibrail Society of Blinds, Udaipur for her work in creating awareness among the rural women in Udaipur district regarding health related issues, promotion of literacy and population control and for 2008 was Smt. Rajni Kumar, Chairperson, Springdales Education Society and Honorary Adviser, Delhi Schools Literacy Project for involving the school students in large numbers to educate adult illiterates belonging to socially and economically deprived sections of the society in Delhi.









The recipients of Nehru Literacy Award for 2006, 2007 and 2008 were Dr. Jaipal Tarang, Faculty Member in the Department of Education, Jamia Millia Islamia, New Delhi (Posthumous) for the creative literacy materials developed by him for non-literate and neo-literate learners, Prof. S.Y. Shah, Professor, Group of Adult Education, School of Social Sciences, Jawaharlal Nehru University, New Delhi for teaching, research, writing, extension work in the field and international cooperation and Shri Kailash Chandra Pant, Secretary Director, Madhya Pradesh Rashtra Bhasha Prachar Samiti, Bhopal for his active participation in the literacy movement and community development work in his capacity as the President of the Madhya Pradesh Proudh Shiksha Sangh. The Award for Late Dr. Jaipal Tarang was received by Smt. Reeta Rani, his daughter-in-law.

The function started with Vandana by Smt. Shobhana Rao. Thereafter, the welcome address was given by Shri K.C. Choudhary, President, Indian Adult Education Association. He said that the Association is a pioneering institution in the field of non-formal, adult and lifelong education with 70 years of standing and recalled the services rendered by persons like Dr. R.P. Masani, Dr. Amarnath Jha, Shri N.K. Mukherjee, Dr. Zakir Hussain in nurturing the institution and meeting the wishes of Mahatma Gandhi for his clarion call to educate people on





self rule and wellbeing. He said that the whole world looks at Dr. Kalam as a Scientist but the educationists always see him as a teacher as he never missed an opportunity to interact with the students and show them the right way to be the best citizens of India. He also said that his very presence in the function shows his interest in the social sector in general and education in particular.

After receiving the awards from the Chief Guest the award winners gave their acceptance speeches.





Dr. APJ Abdul Kalam in his inspiring address said that for any nation, the level and quality of education is one of the most significant parameters for development. In India the literacy percentage has gone up over the years but the quality needs tremendous improvement. Education is not just the ability to read and write but also a complete process of human transformation. Hence, the synergy between education and learning has to be well perceived and operationalised. Education is essentially an aid to generate worthwhile learning. Learning itself is ultimately an individualized and lifelong process, whereby human transformation occurs within the individual. Learning has various forms

such as pre-learning, reinforcement of learning, classroom learning, individualized and independent learning of small groups or large masses, enrichment learning, self learning and self directed or self managed learning. Final result of the learning is the application of knowledge and skills for the benefit of the society, nation and the world. Adult education can contribute to human resource development.

He said that basically adult literacy empowers the citizens with education and facilitates higher order



transformation of society. In a knowledge society it will have added significance of continuous updating of knowledge. What is known today may not be adequate for tomorrow. What was known earlier may have to be researched for new understanding. The digital world has enabled a huge amount of knowledge and information which can be enabled through conventional teaching processes and autonomous learning methodologies. With regard to modern distance communication tools to impart adult education, Dr. Kalam was of the opinion that the single most obstacle is generation of software content as it requires a mission mode operation integrating the efforts of government, NGOs and individuals. He desired Indian Adult Education Association to contribute in this important area.

Dr. Kalam stressed the need for involvement of students in literacy teaching. He said that at any given time 10 million students study in 18,000 colleges all over the country and 13 million students study in higher secondary schools. If they are deployed as volunteer teachers they can make the India literate in short span of time.

He concluded his speech by stating that adult education and adult empowerment are essential prerequisite for development. It is about empowerment and it is about enabling the adult to use his/her faculties to receive and transmit knowledge. It is about educating on the rights and responsibilities and protecting them from



injustice. It is also about educating on the basics of hygiene and disease prevention. It is about projecting avenues for growth and paving the way for new generations with knowledge power.

At the end, Dr. Madan Singh, General Secretary Indian Adult Education Association proposed vote of thanks. He said that the speech of Dr. Kalam was

like a scholar in the field of education delivering a research paper on adult education. He congratulated all the award



winners and said that they are the leaders in the field of adult education and models for others to emulate.

The function ended with National Anthem.



(3) Training Programmes/Workshops Organised

- A two-day training programme on Library Management was organised by IAEA at Churu, Rajasthan on January 19-20, 2009 in collaboration with Zilla Saksharta Samiti, Churu. The participants were Preraks and Coordinators. This was coordinated by Shri S.C. Dua, Consultant, IAEA.
- A five-day Capacity Building Training to the members of the staff of State Resource Centre Deepayatan, Patna was planned and conducted by IAEA from October 6-10, 2009 in the office of the Association at New Delhi. In all 11 persons attended the training. The programme was inaugurated by Shri K.C. Choudhary, President, Indian Adult Education Association. Dr. Madan Singh, General Secretary, Indian Adult Education Association also addressed the participants.

(4) Outreach Activities





• As part of outreach activities, IAEA has established a Centre for Lifelong Learning at Trilokpuri in East Delhi, which is a resettlement colony where residential plots are given to jhuggi dwellers. People living here belong to different states and with different cultural background. Most of the people belong to low income group and below poverty line.

This centre has two vocational courses - Beauty Culture and Health Care and Cutting and Tailoring.

Indian Adult Education Association in collaboration with the National Human Rights Commission (NHRC)



organised a one-day training programme on Human Rights on July 10, 2009 at Bal Vikas Vidyalaya, Trilokpuri for the beneficiaries of the NGOs working in the resettlement colony, Trilokpuri. 125 persons participated in the programme out of which 88 were women.

Shri K.C. Choudhary, President, IAEA welcomed the participants and resource persons. Prof.

B.S. Garg, Patron, IAEA and Chancellor, Janardan Rai Nagar Rajasthan Vidyapeeth University, Udaipur gave the inaugural address.

The academic programme was divided into five sessions. The first session was presided over by Shri H.C. Parekh, IRS (retd.), Member of the Executive Committee of IAEA and addressed by Shri S.K. Jain, Senior Research Officer, NHRC on the structure and work of National Human Rights Commission.

The second session was presided over by Dr. M.S. Ranawat, Treasurer, IAEA and the lecture was delivered by Shri Ramesh Pranesh, Director, Gender Resource Centre, Sarthak, Bapudham, New Delhi on Women and Human Rights.

The third session was presided over by Shri A.L. Bhargava, Joint Secretary, IAEA and the lecture on Right to Information was delivered by Ms. Santosh, Social Worker and RTI Activist, Parivartan, Nand Nagri, New Delhi.

The fourth session was on the challenges before adolescent girls with special reference to the sexual harassment. This session was presided over by Shri Prem Chand, Senior Consultant, IAEA and the lecture was delivered by Ms. Mohini, Programme Manager, Pratidhi, New Delhi.

The fifth and last session was on Police and Human Rights. S/Shri Y.S. Chauhan and Amit Chadha, Advocates, Delhi High Court took the session. This session was presided over by Shri S.C. Dua, Consultant, IAEA.

Dr. Madan Singh, General Secretary, IAEA gave the valedictory address.

• IAEA in collaboration with Eye Care Foundation, Mumbai organised a fourdays Eye Camp from July 20-23, 2009 in Balvikas Vidyalaya, Block 8, Trilokpuri. Around 500 school students and women learners of vocational courses run by the school underwent eye check-up by a team of qualified doctors and technicians under the leadership of Dr. Ruma Gupta from Vision 2020 organisation. Preliminary screening results showed that 76 students had eye related problems and they require further examination in the lab setting. IAEA facilitated the same.

All the children who came for eye check-up were given Nutrila Chunks packs by Savour India Pvt. Ltd., Janakpuri, New Delhi free of cost.

(5) Evaluation

• External Evaluation of Post Literacy Programme in Thane District, Maharasthra was conducted from February 4-14, 2009. The evaluation team was headed by Shri Prem Chand, Senior Consultant. 13 Blocks and 6 Municipal Corporations were covered. 74 randomly selected villages and urban areas were visited by the field investigators and collected information by using interview schedules. The team was assisted by Marathi speaking college students to collect the data.









interviews were also conducted with the representatives of the village community, members of the village

level committee for CE and other persons who were involved in the programme. External Evaluation of Project Residual Illiteracy (PRI) of Pilibhit district in Uttar Pradesh was conducted from March 18-24, 2009. The evaluation team was headed by Shri Prem Chand, Senior Consultant, Shri SC Dua, Consultant and Shri Rajesh Choudhary, Assistant Director. The data was collected in 49 villages of seven blocks and three urban centres at Pilibhit, Jhanabad and Vilsanda municipal areas. Seven percent of the sample learners who have completed Primer-III

External Evaluation of the Continuing Education Programme of Jhalawar district in Rajasthan was conducted from March 4-9, 2009. The evaluation team was headed by Shri Prem Chand, Senior Consultant and Shri SC Dua, Consultant. The data was collected in six Panchayat Samitis (CD Blocks). Ten percent of the sample CECs and NCECs viz. 43 CE centres and 4 NCE centres were visited by the team. Detailed discussions were also held with the district officials, block coordinators, preraks and assistant preraks. To get feedback relating to the functioning of the programme in different parts of the district

- had been administered tests and also interviewed. Data also was collected through interview schedule from Panches/Sarpanches, District Coordinator, KRPs, MTs, Block Coordinators, Nyay Panchayat Resource Coordinators and VTs.
- External Evaluation of Baramulla district Total Literacy Campaign was conducted from April 15-23, 2009. The evaluation team was headed by Shri Prem Chand, Senior Consultant, IAEA. The data was collected from 12 C.D. blocks. Block Coordinators and Volunteers were also interviewed.
- External Evaluation of PLP of Dantewada district of Chhattisgarh was conducted from November 26, 2009 to December 1, 2009. The evaluation

team was headed by Shri Prem Chand, Senior Consultant, IAEA. The data was collected from different blocks of the district. Neo-literates, functionaries at different levels and community representatives were also interviewed during the conduction of the evaluation study.

(6) Publications

The following periodicals were published in 2009:

(7) Dr. Mohan Sinha Mehta Research Fellowship

IAEA invited research proposals for Dr. Mohan Sinh Mehta Research Fellowship for 2009 through a notification in the IAEA Newsletter June 2009. The major objective of the fellowship is to bring out quality research paper which would be of use both to the planners, administrators and field functionaries.

The fellowships are available to individuals interested in undertaking research in the area of adult education, continuing education and lifelong education.

Suggested topics were:

Case study of a successful programme.









- Success story of an individual or group of individuals.
- State Resource Centre as an institution of excellence in the area of literacy material development and training.
- Jan Shikshan Sansthan as an institution of excellence in the area of vocational education.
- University Department of Adult Continuing Education and Extension as an institution of excellence for outreach activities.
- Ways and means to accelerate female literacy before 2011 census.
- An enquiry into the factors promoting and intervening in retention of literacy by neo-literates.
- Role of adult education in reducing poverty.

A sum of Rs. 50,000/- will be awarded for each fellowship which will be released to the institution responsible to administer and manage the funds in three installments - 40% of the total amount as first installment immediately after acceptance of the proposal, 40% of the total amount as second installment immediately after the receipt of draft report and acceptance of the same by IAEA and the remaining 20% of the total amount as third installment after five copies of the final report is received, complete in all respects by IAEA.

The study needs to be completed in one year from the date of release of the first installment.

Proposals have been received and are under scrutiny.

(8) Certificate Course in Library Science

IAEA is an accredited institution of the National Institute of Open Schooling (NIOS). During the year of reporting, IAEA conducted Certificate Course in Library Science in which 11 candidates got coaching and also appeared in the examination conducted by NIOS in November 2009.

(9) Documentation Centre

During 2009 the following activities were conducted:

- Published four issues of the quarterly Indian Journal of Population Education. The journal contains articles on issues relating to population and development education such as population stabilization, Health and Family Welfare, Adolescence Education, HIV/AIDS, Gender Issues, Women Empowerment etc.
- Six issues of bi-monthly Newsletter Literacy and Population had been printed and widely distributed. This Newsletter aims at providing latest information on issues relating to population and development education and reports on the programmes conducted by the State Resource Centres and Jan Shikshan Sansthans.
- One issue of Adult Education Index containing bibliographical citation of latest books, articles on adult education, adult literacy, adolescence issues and issues concerning HIV/AIDS was printed and distributed.
- One Bibliography prepared on "Lifelong Education". It contains citations on books and articles on lifelong learning.
- Information Repackaging Service
- Effective Literacy Practices : International Experiences it is a compilation of 34 successful adult education projects from 28 countries around the globe.
- Compilation of summary reports of International Conferences on Adult Education, 1 to 5. It provides trends of adult literacy/adult education during various periods.
- Collected the press clippings on various issues concerning right to information, gender issues, infanticide/foeticide, abortion, women health, literacy/adult education programmes, street children etc.
- Prepared a digital database of literacy and post literacy primers. It contains primers received from 18 State



Resource Centres. During total literacy campaign and Post-Literacy Progammes almost all the districts had developed primers keeping in view variation of dialects in a particular region within a state. PDF Files of primers have been created for easy access of the contents.

• Provides reference services to the readers who visit the Centre apart from providing reference service through E-mail. During the reporting period 27 scholars used the resources available in the library. 129 new documents on adult education and related fields have been added to the library.

(10) Activities of State Branches

• IAEA UP State Branch Meeting was held on February 14, 2009 at 2:00 p.m. at Charan International, Hazratganj, Lucknow. Shri K.C. Choudhary, President, IAEA attended the meeting as the observer. 25 members attended the meeting and elected unanimously Dr. Madan Singh as the Chairman and Dr. O.P.M. Tripathi and Prof. P.P. Singh as Vice Chairmen. Other office bearers elected were Dr. S.C. Upadhayay (Secretary), Shri Sudhakar Man Singh (Joint Secretary) and Prof. Irshad Husain (Treasurer).

Shri P.K. Sundriyal, Dr. Uma Bisht, Shri Avinash Kumar Mishra, Smt. Kusum Mishra, Dr. Usha Rai, Shri S.P. Rastogi, Shri K.B. Tuteja and Shri R.C. Yadav were elected as members. Dr. Dilip Kumar and Dr. N.K. Verma were selected as Co-opt Members.

The members of the state branch also constituted two sub-committees, one for bringing out Newsletter of the state branch and another one for generating resources for the branch.

• A one-day Seminar on Religion, Terrorism, Tolerance and World Peace was organized by Indian Adult Education Association, Bihar State Branch on February 16, 2009 in collaboration with Maha Bodhi Society of India, Bodh Gaya Temple Management Committee and Inter-Faith Forum in the premises of MBSI Bodh Gaya. The participants of the seminar were academicians, politicians, bureaucrats, religious leaders, social and community workers from Bhutan, India, Indonesia, Japan, Korea, Sri Lanka, Thailand, Tibet, UK and USA.

A theme paper was presented by Shri A.H. Khan, Vice President, Indian Adult Education Association. In his paper he dealt in depth regarding the core contents and real essence of all the major religions based on

humanity and truth. He said the terrorism is the worst enemy for humanity and peaceful co-existence.

IAEA, Karnataka State Branch, Dharwad organised a one-day Seminar on Adult Education on February 26, 2009 in collaboration with K.R. Bellad Arts and Commerce College, Mundargi. Three speakers who addressed the participants on different aspects of Adult Education were - Shri G.S. Hegade, Basavanakatti, Sirsi on Continuing Education, Shri A.Y. Navalagund, Mundargi on Adult Education - Role of College Students and Smt. G.S. Hasabi, Mundargi on Women and Adult Education. Each lecture was followed by a discussion.



(11) Visits Abroad

• On the invitation of German Institute for Adult Education, Shri K.C. Choudhary, President, IAEA and Chancellor, International Institute of Adult and Lifelong Education is visited, Germany from March 23-25, 2009 for an international meeting between the organizations concerning the professionalisation of lifelong learning and the





infrastructure of lifelong learning with a special emphasis on teacher training.

• The Vice President of the Indian Adult Education Association, Prof. S.Y. Shah and the Associate Secretary of the Association Dr. P.A. Reddy attended Asia-Europe Conference on Teachers and Trainers in Adult and Lifelong Learning organised jointly by the German Institute for Adult Education, University of Duisburg Essen, Romanian Institute for Adult Education, Consortium of European Research and Development Institute for Adult Education at Bergisch Gladbach, Bonn in Germany on June 29-30, 2009. While Prof. Shah presented a paper on "Teachers and Trainers in Adult and Lifelong Learning: Indian Scenario", Dr. Reddy's paper was on "Lifelong Learning in Indian Universities". Prof. Shah also moderated a session on Teachers and Trainers Role and participated in a Panel discussion on Problems and Prospects and also exhibited a Poster on Professionalisation of Adult Education in India.


